## **The Injunction Order**

An application was made today on notice to the Defendants, on the 15 May 2017, by Oliver Ingham, Counsel for the Claimant to THE HONOURABLE MR JUSTICE KING sitting in the Queen's Bench Division of the Royal Courts of Justice.

UPON permission having been being given for substituted service by the placing of a comment upon the website <https://nunaminerals.wordpress.com> pursuant to CPR 6.15 by order of the Honourable Mrs Justice Lang

And as a result of that application

### **IT IS ORDERED THAT:**

1. The Defendant refrain from re-uploading the webpage hosted at <https://nunaminerals.wordpress.com>;
2. The Defendant refrain from making any publication which states that the Claimants are involved in fraud or criminality, or that their launch of Newco is fraudulent except other than by a report to a competent governmental authority/regulatory body and in any event without publication of the same on the internet;
3. Costs reserved.

## GUIDANCE NOTES

### **Effect of this Order**

1. A Defendant who is an individual who is ordered not to do something must not do it himself or in any other way. He must not do it through others acting on his behalf or on his instructions or with his encouragement.
2. A Defendant which is a corporation and which is ordered not to do something must not do it itself or by its directors, officers, employees or agents in any other way.

### **Variation or Discharge**

The Defendants (Or anyone notified or in this Order) may apply to the Court at any time to vary or discharge this order within 7 days, but anyone wishing to do so must first give 3 days notice, in writing, to the Claimant's legal representatives. Except that the hours between 5pm on any Friday and 9am on any Monday cannot be counted as part of the 48 hours period.

### **Parties other than the Claimant and Defendant**

It is a contempt of Court for any other person notified of this Order knowingly or to assist in or permit a breach of this Order. Any person doing so may be fined, sent to prison or have his assets seized.

### **Interpretation**

In this Order, "persons unknown" means the persons responsible for operating the web page <https://nunaminerals.wordpress.com>, or any other person who is responsible for posting onto that page, or otherwise contributing to the content.

In this Order, where there is reference to more than one Defendant, unless otherwise stated references to "the Defendant" means all of them.
